- 3 Yr Life : Uniforms, Videos, Rental Wearing Apparel, Cell phones
- 4 Yr Life : PC Computers, CPU'S, Laptops, Digital Cable Boxes
- 5 Yr Life : Hand Tools, Daily/Wkly Rental Equip & Furn, Commercial Lawn Equip, Air Med Beds, molds, dies
- 6 Yr Life : General Computer Equip:Peripherals, Servers, Cabling, Faxes, Copiers, Cellular Transmission Equip
- 6a yr Life : Data handling equipment, except computers, radio and television broadcasting, Televisions, Alarm Systems
- 7 Yr Life : High Tech Medical Equipment(MRI, PET Scan, Ultra Sound, Laser, Dialysis Equip and other computerized Medical)
- 7a Yr Life : Restaurant Equipment - Fast Food
- 8 Yr Life : Computer Assisted Equip (Eng Analyzers, CNC Equip), Small Laundry, Phone Systems, ATM's , Retail Fixtures, Heavy Construction Equip (Wheelloaders,Cranes)
- 9 Yr Life : Restaurant Furniture & Equip, Forklifts, Display Coolers
- 10 Yr Life: Furniture, Office Fixtures, Office Equip (Telephones, etc.), Signs, Hospital Equip Machinery, Equipment (Includes Large Laundries), Leasehold Improvements (Requires Detail) Printing Equipment
- 12 Yr Life: Bakeries & Confectionery Prod, Brewery Equip, Metal Prod Fab Equip, Food & Bev Prod Equip, Motor Vehicle & parts Mfg.,Ship & Boat Building Mach & Equip, Soft Drink Manuf & Bottling
- 18 Yr Life: Wooden Billboards
- 20 Yr Life: Towers, Solar Panels,
- 25 Yr Life: Monopole/Steel Billboards, Tanks
- 30 Yr Life: Vault Doors, Safety Deposit Boxes, Modulars, Vaults
